I/(we) hereby authorize Ocean of Light Summer School, or its designated representative, as agent(s) for the undersigned, to consent to any xray examination, anesthetic, medical or surgical diagnosis or treatment and hospital care which is deemed advisable by, and is rendered under the general or special supervision of any licensed physician or surgeon on the medical staff of a licensed hospital, whether such diagnosis or treatment is rendered at the office of said physician or at said hospital. As the parent/guardian of a minor under the age of 18, I understand that this authorization enables Ocean of Light Summer School to arrange medical care for my dependent minor in the event I am unavailable.

I understand that I am responsible for payment of any and all medical expenses incurred on behalf of myself the minor(s) listed above. This authorization shall remain effective from June 28 – July 6, 2025.
